# B. TEACHER EVALUATION

# 1. EVALUATION OF THE RESEARCH ACTIVITY OF CONTRACTED TEACHING AND RESEARCH STAFF

In 2024, AVAP, through its committees of experts, evaluated the research activity of the contracted teaching staff of **Miguel Hernández University of Elche (33 files).** This evaluation is carried out by applying a procedure and evaluation criteria comparable to those used by the CNEAI to evaluate teaching staff belonging to university teaching bodies.

A total of **33 applications** have been evaluated this year.

# 2. ASSESSMENT OF ADDITIONAL REMUNERATION FOR UNIVERSITY TEACHING STAFF

In accordance with the provisions of **Decree 174/2002 of the Valencian Government** and the **Resolution of 21 January 2011** of the presidency of AVAP, AVAP is responsible for the assessment of individual merits for the establishment of additional remuneration linked to individual teaching, research and management merits of civil servant teaching and research staff, regulated by Decree 174/2002 of 15 October 2002 of the Valencian Government.

AVAP evaluates **the mobility component,** indicating the classification in three different levels of quality.

In 2024, 115 applications were assessed for the qualification of university teaching staff mobility:



# AVAP strengthens its structure and functions with the adoption of updated regulations
